Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/10/11 vesting of 16,200 of the 48,600 shares of restricted stock Mr. Ennis was granted on 12/8/08. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- Of the 51,368 shares beneficially owned, 16,200 shares are unvested restricted shares that the reporting person was granted on 12/8/08 which vest on 1/10/12.
